Return and Refund Policy

- Refunds on the products and services will be accepted in situations limited to the following:
 - (1) The products are damaged or faulty
 - (2) The products are lost during shipping
 - (3) The products received are incorrect (do not correspond with the order submitted by the customer).
 - (4) The products you ordered missed from stocks.

To complete your refund, we require a receipt or proof of purchase. The money will be refunded to the person who purchase the item (to his master card, visa card etc) which include the same information he/she used to purchase.

We will not accept third party and will not send money to him/her.

Refunds will be done only through the Original Mode of Payment.

Note: - the refund will be completed within 60 days.
